- A. Swimmers attending meets without coach must show diving card or be certified by a coach at the meet or start in the water.

NEW wording to be added to all meet forms: “Any swimmer entered in the meet, unaccompanied by a USA Swimming member coach, must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. It is the responsibility of the swimmer or the swimmer’s legal guardian to ensure compliance with this requirement”
