Entry Deadline:	Entries must be received the meet processor no later than 5 pm Wednesday, July 7, 2010. If the meet fills prior to the deadline, entries will be rejected. (last received, first rejected.)
Location:	Paul Nelson Pool, 516 S. McClelland, Santa Maria, CA. Exit Highway 101 onto Main Street and proceed west to Santa Maria Town Center Mall. Turn left onto Miller Street. At the first signal, make right onto Cook St. Proceed 1 block and turn left onto McClelland. The pool is approximately halfway down the block on the left. Parking is available at the pool, across the street at DMV and at the mall
Course:	PNAC is a 50m by 25y, outdoor, heated pool with a separate 25 yard pool. The competition course has been certified in accordance with 104.2.2©. Pool depth: Start end 9ft, turn end 4ft.
Warm Up Policy	Practice starts or diving from either the starting blocks or the pool edge area not allowed during warm-up except under direct supervision of a USA Swimming member coach. At the discretion of the Meet Referee lanes 2 & 7 may be designated as sprint lanes (practice starts permitted under coaches supervision with one-way swimming from the blocks) and lanes 1 & 8 may be designated for push-pace work (times to be announced). Marshals will be designated to oversee the warm-up procedure and pool. No horseplay is allowed in the warmup pool. This policy will be strictly enforced.
Check-In:	Swimmers must check-in with the Clerk of Course for each event entered. After an event has been officially closed, swimmers <u>MAY NOT CHECK-IN OR SCRATCH</u> . Swimmers in the first 4 events of each session must check-in at least 20 minutes prior to the start of that session. Swimmers who check-in and fail to swim an event will be scratched from their next individual event.
Rules:	USA Swimming rules will govern. Current SCS meet procedures will be used and take precedence over any errors or omissions in this form. The Meet Referee will be in charge of the meet. Any questions regarding the conduct of the meet should be directed to that person
Eligibility:	Open to athletes who are 2010 USA Swimming registered. Registration applications must be received by the meet host or SCS office the Monday prior to the first day of the meet. REGISTRATION APPLICATIONS MAY BE SUBMITTED TOGETHER WITH ENTRY FORM. There are substantial penalties to swimmer and Club (see 2010 SCS Swim Guide, part One, III, B) if USA registration is completed at meet.
Swimwear:	Swimsuits for men may not extend above the navel or below the knee and for the women may not cover the neck or extend past the shoulders or below the knee; no zippers or other fastening devices are allowed except a waist tie on a brief or jammer; suits must be of a textile material (no polyurethane or neoprene). An athlete may wear a single set of garments underneath his or her competition swimsuit for modesty/privacy reasons.
Submitted/ Qualifying Times	Times submitted must be BEST RECORDED TIMES short course or long course from this or preceding swim season (NO WORKOUT TIMES). All non-conforming times will be seeded last. Coaches and swimmers should be prepared to verify all submitted times. Discrepancy in the submitted times can lead to disciplinary action. "No Time" will be accepted for the WHITE division. Meet management will limit entries in order to ensure compliance with the 4 hour rule.
Entry Procedure:	Use one SCS consolidated white entry card per swimmer to enter this meet. Card must be filled out completely, including entire USA Swimming registration number. Non Southern California athletes are requested to submit a copy of their 2010 USA Swimming card along with entry. Hy-Tek Team entries with one team check are highly encouraged.
Electronic Entry Policy	#1 E-mail entry (entry.zip file) will be accepted only when received with an attached Word or .pdf file including electronic signature of the coach and will be dated as official at that time; a 5:00pm postmark would queue before a 10:00PM electronic. #2 Full payment (a single team check) for an e-mail entry must be postmarked within 48 hours of the e-mail entry. Failure to comply will be referred to the Board of Review. #3 Entry updates (added events) will be processed when received by the processor by the entry deadline. Added events (entered swimmers) may be submitted by hard copy ONLY (this includes e-mail). New swimmers accepted SPACE AVAILABLE #4 DO NOT RESEND AN ENTRY FILE: a replacement file for the team will not be processed. Deletions will not be refunded.

Fee:	\$3.00 per INDIVIDUAL event plus a \$7.00 surcharge PER SWIMMER. A check for the total amount (made out to SCS) must accompany each entry to the address below (NOT THE SWIM OFFICE). You should enclose a self-addressed, stamped envelope to confirm receipt of your entry. NO REFUNDS. RETURNED CHECKS WILL INCUR A SERVICE CHARGE.
Awards:	Awards for 12 and under swimmers only. 1-8th place in each division, "B, R, W" 10/under swam together and awarded as a single age-group.
