# Nathan Wilcox (NOVA/Chair):

#### Discussion re 2022 Meets:

- EAST Meet cancelled due to non-participation.
- STOP cannot host, meet is single site.
- Question: Teams not participating in Orange Committee meets. Orange Committee
  teams were asked to respond with numbers and intent to enter scheduled Committee
  meets, some have replied with data, some teams have not responded at all. The
  purpose is to determine viability of meets and to more intelligently assign teams based
  on real time interest, not mere historical numbers. Teams are requested to participate.
- Numbers:
  - o 515 committed to the AAA Meet, that event is struggling for officials;
  - 345 committed to SET 7 teams have not responded;
  - BB Max Meet 335 at the EAST location, 415 at GWSC is this viable?
- Concern: Teams liked running small dual meets during Covid, will want to keep running small meets. Goal is for teams hosting Committee meets to break even. Also a consideration is availability of officials.

**Covid Relief**: Discussion re Request for Covid Relief from SCS.

**Officials**: Discussion regarding the cost of officials, pay to officials working meets. Some members suggest working as a committee to change and decrease costs. Also, to find a way to make events shorter.

**Meet Labeling/Naming**: Discussion re how best to label BB+ meets so that families understand what level of meet is being offered as we transition from BRW to the National Time Standard format. Parents are confused, and the meet naming is contributing.

<u>Treasurer (Teresa Wilson)</u>: Balance as of January 25, 2022 is \$25,136.90 (source SCS).

<u>Coaches' Chair (Danylo Proskura)</u>: No report.

Age Group (Kevin Little): Short course meters season being discussed.

- On January 14, 2022 a document from the SCS Officials Chairs titled "2022 Official Certification Criteria 1-1-2022" was forwarded to all Orange Committee officials, with a request to review and provide comment. This document offers an opportunity for all member officials to provide input to the Officials Certification criteria used in Southern California Swimming. The comments from Orange Committee officials are due to Judi Divan by January 28, 2022, and she will collate all comments and return everything from the Orange Committee officials to the SCS Officials Chairs on January 31, 2022. All Orange Committee officials are encouraged to participate in this important process and submit comments.

Concern: male athletes are not included in the program, and all 13U athletes could benefit. Also, believed that adults should be involved in the discussions or at least present, not only kids/athletes.

- February AAA Meet: Officials issue being worked on, confident will be worked out.
