High school meets will only be observed if the pool has been certified. Because USA-Swimming
meets are being held in uncertified pools, a motion was made to adhere to the USA-Swimming
wording requiring pools to be certified. As of September 1, 2009, pools must be certified in order
to get a USA-S sanction. At the senior meeting, the calendar for next year was defined. Based on
the numbers from this year's Grand Challenge, a senior development meet will be added next
April.

- 4. The 2010 Summer Sectionals have been awarded to Canyons! A meet host for JOs will be needed to replace Canyons; it would be nice for another Coastal team to take this on.
