Membership of the Planning Committee: • Administrative Vice-chairman • SCS athlete representative • Coach and athlete representative from each SCS geographic committee. • Age Group and Senior Chairmen • Officials' Chairman • Coaches' Representative

Responsibility of the Planning Committee: Develop a proposed SCS competition calendar for the age group and senior programs of SCS. Calendar is to be presented to the April Board of Directors meeting. Upon acceptance by the Board of Directors, all clubs shall be notified and given the procedures and documentation required for bids to host the meets. Bids will be heard and meets awarded at the June Board of Directors meeting.

Recommendations:

1. Planning, working closely with the Senior Committee, should look closely at adjustments to the 2019 / 2020 Senior calendar in preparation for the 2020 Olympic Trials.
2. Planning should work closely with the Open Water Committee to expand the open water competition calendar, as well as, couple new open water events with existing pool events.
3. Time Standards for Kevin Perry Senior Invitational be adjusted.
4. Seven event-limit be established for Kevin Perry Senior Invitational
5. Kevin Perry Senior Invitational be considered for short course prelim and long course final format in 2019.
6. The Senior Q challenge, at the preliminary geo-committee level, use a standardized senior meet format for all committees as the first step prior to the February Senior Q Challenge.
7. Planning should move forward with a Colorado Springs All-Star event to be tied to the Senior Challenge.
8. Planning, working closely with the Senior Committee, should evaluate and revise the SCS Senior Development Time Standards for 2019 / 2020.
