#### Minimum Deck Officials for an SCS Deck

Recommend: Five (5) Deck Officials for a multi-session, multi-day meet

1 must be a certified referee, 1 must be a certified Starter, others can be S&T

Jurisdiction: **Deck Referee** – In charge of all that is happening in the water,

confirms false starts. By rule cannot act in other positions.

**Starter** – Insures a fair start, verifies correct swimmers are in the water, calls false starts. Can act in other positions after the start.

**Chief Judge:** Informs the swimmer and or coach of disqualifications. Can act in other positions.

**Stroke and Turn** – Insures that the USA-S stroke rules are conformed to during competition. Can act in other positions as long as properly certified. Can judge 4–5 lanes from edge closest to judge.

Reduced Deck: Under certain situations, a deck with less than the recommended number of officials is acceptable. It is the responsibility of the meet referee to work with the hosting club to determine that the meet is sufficiently staffed to insure that the times achieved by the athletes are valid. The length of the meet and interval timing of heats should be taken into account when staffing a meet. It is the deck referee's responsibility to insure that all officials are in position before a heat is started.

Examples of acceptable reduced staffing:

- If both sides of the pool are accessible so that an official can walk the entire distance on each side (stroke and turn/chief judge on far side, starter on near side), then the staffing can be reduced to 3 or 4 total officials. Notes:
  - o Each official can have jurisdiction over no more than 4-5 lanes
  - The interval between heats may need to be increased to allow for the offside official to talk to a swimmer and return to their position.
  - The expected duration of the meet and weather conditions must be taken into account so that officials can get appropriate breaks
- If only 4 or 5 lanes are needed due to meet size.

Notes:

- o The reduction is dependent on adequate access around the deck.
- During freestyle events the deck can be reduced to a level such that an official can clearly see all lanes and that the swimmer has made contact with the wall and not used the pool bottom.

Cost Of Officiating: USA-S officials are volunteer officials, no fees are set by Southern California Swimming or USA-Swimming. The host team is responsible for staffing all meets except for LSC level meets (meets that are bid at the LSC BOD meetings). Host Clubs are encouraged to identify potential officials, who can then be trained by certified Southern California Swimming officials. Any agreement of compensation for officiating is between the club and the officials. It is highly recommended that the club and the officials have an agreement in place prior to the meet
