Robin welcomed everyone to the first OW Committee meeting of 2022 and introduced the new members.

COMPETITION:

1. The Committee discussed placeholder open water meets and potential additional venues for the 2022 SCS Open Water Calendar. It was noted that the Huntington Beach Pier Swim has not yet set a date for their 2022 event. Draft calendar is appended to this document.

2. SCS OW JO's 2022 Host – due to the uncertainty with venues and open water meets moving forward, committee discussed possibility of having hosts of current meets bid instead of new hosts/venues.

3. Discussion around issuing special event permits for race venues in 2022. Recommendation is to confirm who is in charge of the body of water and who will provide the lifeguards/safety to determine the permitting process.

EDUCATION:

1. Brainstormed ideas for OW Clinics and Age Group OW Camp. Suggestions ranged from having a clinic at a meet venue before the races to using pool space for both clinics and open water events during pool meets.

2. Committee discussed the "parent's" perspective on OW and OW Safety. Suggestion to finalize the draft training presentations and place on new SCS website for everyone to access.

SUPPORT:

1. Robin confirmed the proposed SCS Club Support amounts for 2022. OW will use the same criteria and formula as Pool. The proposal is in the process of being approved by the SCS BOD. Proposed amounts for the upcoming 2022 OW Nationals/Jr. Nationals in Fort Myers FL: \$1300 for Nationals, \$900 for Jr. Nationals, plus one coach each per 10 athletes.

2. Paul gave a brief update on the current status of OW Officials certification process.
