- I. Meeting called to order by S. Gainey at 8:03 p.m.
- II. May 2010 Minutes were approved as corrected—the corrections being 1) ASCA World Clinic in September in Indianapolis 2) Mt. Baldy requested permission to swim a dual meet with FAST the same weekend as RAA, not the HVDA meet (item 16).
