REPORT

1. 2022 Swim Guide is complete and online. Club contact information has been updated to match Swim Guide content. Committee board and BOD have also been updated to match Swim Guide Content. Many updates have been added to the Swim Guide since Jan 1 for contact information and calendar, etc. Will continue to update Swim Guide as meet schedules, etc. change.
2. New season began 9/1/2021. From 9/1-4/12/2022 I have loaded 192 meets into SWIMS, including age group and senior meets. Six (6) meets were Approved, three (3) were Observed; the other 183 were Sanctioned.
3. Time standards are updated as of 1/1/2022. BRW time standards are available for reference only in the Forms section of the SCS website.
4. Published SCSRT LCM and SCY on 9/30, 10/31, 11/30, 12/31, 1/31, 2/28 and 3/31.
5. Updated and published SCS Records (September 30, Dec 31, and March 31); the next Records update will be June 30.
6. Ad hoc reports and addition of intermediate splits at coach request. Added "missing" US-UN times for swimmers who registered with SCS after 2021 CIF.
7. Generated vertical cut files for swimmers new to teams.
8. Ran Times Recon for the Kevin Perry meet, SCAT and GWSC WAG meets and Sectionals and Road to 2022. Also ran Times Recon for the Orange Committee AZOT JO Max meet. Ran Times Recon for 2022 Spring JO's and SMOC.
9. Posted all submitted Results and Upcoming meets to the SCS website. Added all calendar events for the posted meets to the SCS Calendar.
10. Generated files (Top 80+ per age group, aged to meet date) for Chris Barber, Age Group Chair to help in selection for Pacific Coast Allstars and Festival.
11. Generated numbers of attendees by team for Chris Barber, Age Group Chair for 2017-2021 JAG (2020 omitted, 2021 WAG substituted for JAG) and for 2017-2019+2021 Summer JO's.
12. Generated meet template (shared by all 3 team hosts) for 2021 WAG and 2022 JAG, and also a common MM database (MM setup must be the same for multi-host in order to combine after-the-fact. Generated meet template and MM database for 2022 Summer JO's. These have been forwarded to Chris Barber, Age Group Chair. Chris subsequently forwarded the JAG and Summer JO information to each meet admin.

13. Completed setting up a spreadsheet showing 48th and 56th (6 & 7 heats of 8, respectively) for 2017-2019 + 2021 Summer JO's at the request of Chris Barber, Age Group Chair for the committee to work on a new set of time standards, possibly for a combined JO's.
14. At the request of the Club Support committee, looked up in SWIMS the number of years for each listed athlete where the club was seeking reimbursement from SCS. Swim Guide currently has 4+ years at 100% of stipend, 3 years at 70%, 2 years at 40% and 1 year at 10%.
15. At the request of Keith Moore, WZ Committee, updated both the *.docx and *rec Hy-tek file to bring the WZ Sectionals records up to date. SCY was updated from 2016 & LCM was updated from 2007 to present. Currently updating WZ SCY records for 2022 as of the Carlsbad Sectional meet.
16. At the request of the meet admin; broke Road to 2022 into two meets—one SCY and one LCM as she was unable to post using her meet setup (SCY prelims + LCM finals). There is a double entry in SWIMS for this meet.
17. In the process of getting A and B forms to USA Swimming, Suzanne Heath for 2022 Observed HS meets. A forms are for HS Invites requesting Observation but which are not in the Championship progression. This year there are four (4). B forms are for meets in the HS Championship progression. There are 25+ meets requesting observation so far, and expect 10-15 more. Some meets with a single observation number are multiples. CIF-SS D1-2-3-4 are four meets but sanctioned as one, etc.
