Establish a Coach of the meet for the Metro Summer Festival Meet & Summer Metro Champs. During the last day of the meet, a simple vote with the individual with the most votes be honored. One vote per team. Each team entered will be on the ballot. Each team can assign a coach to represent them. Also, highlight the top two teams in total combined points for each SCS Summer JO. Again, each team can assign a coach to represent them. The winner of the coach of the meet for the Metro Summer Festival Meet, the Summer Metro Champs, and the six Metro coaches whose team placed the best at the SCS Summer JO's will be on the ballot. Voting will be done via an email ballot, and winners will be announced during the Sept. Metro meeting. Metro Committee would supply the winning coach with a custom award."
