2. Coach Michael Kinross (Western Zone OW Chair) and Head Coach Ron Aitken (SAND) presented preliminary draft meet information and answered questions regarding two proposed open water meets to be hosted by Sandpipers of Nevada:

- Las Vegas Open Water Invitational (tentatively scheduled for Saturday September 12<sup>th)</sup>
- USA Swimming Western Open Water Championship (tentatively scheduled for Saturday October 17<sup>th</sup> to Sunday October 18<sup>th</sup>)

The venue for both meets is planned for Lake Las Vegas in Henderson, NV. This is a private artificial lake 15 miles east of downtown Las Vegas and the airport. The meet information is being finalized and sanction applications are in progress. It was mentioned that there is also a tentative USA Swimming Eastern Open Water Championship currently being proposed in the Virginia LSC for October TBD.

3. Robin presented a proposed USA Swimming Open Water Series planned for 2022 with a possible soft-opening in 2021. This series of open water meets will include Elite, Futures, and Age Group competitions across the country. The Committee discussed potential opportunities for SCS participation in the Series.

#### EDUCATION:

1. Reviewed next steps for SCS "Introduction to Open Water Swimming" webinars. These include reviewing updated draft presentation slides and finalizing the over-all presentation plan.
