<u>Treasurer (Teresa Wilson)</u>: Balance reported at \$27,279.87 as of August 5, 2022 (source SCS).

<u>Coaches' Chair (Danylo Proskura)</u>: Coaches are encouraged to consider ASCA membership. <u>Senior Representative (Ken LaMont)</u>: No Senior Race Series, a change to single day junior meets instead. October 23, 2022 at Lakewood, November 20, 2022 at GWSC.

The USA Swimming House of Delegates voted to reduce the "unattached rule" by which a swimmer must unattach from a team when changing clubs from 120 days to 60 days, effective immediately.

## SafeSport Rep (Quincy Kelly):

- <u>SafeSport Recognition</u>: Packet is on hold until the first week of November.
- <u>CANRA</u> required child abuse awareness training for coaches in California is on the USA Swimming website. Deadline is December 1, 2022 for non-athletes, time commitment is approximately 2.5 hours.
- The SCS SafeSport Chair will request that USA Swimming make parent training more time-friendly for the West Coast.
- <u>REMINDER</u>: Teams need to identify their SafeSport team representatives, a name and contact information is to be sent to Quincy Kelly asap. The SafeSport team representative does not have to be a coach.

## Program Chair (Kim Hoesterey):

## **Meet Schedule Changes/Traditional:**

- November, 2022: BREA SCY Meet moved to November 12-13 due to conflict with Kevin Perry on November 3-6
- <u>December, 2022</u>: ORCA is already set to host the Invite meet, but need a second host as NOVA will attend with projected 200-300 swimmers. Devon Ames will inquire.
- January, 2023: BB Minimum SCY meet, January 6-8, 2023, looking for a host. Otherwise, eliminate.

- March, 2023: BB Max on March 18-19 moved to March 25-26 due to Jos
- May have to re-bid some meets on the Orange Committee Invite/Traditional meet schedule

#### **Pilot Swim Meet Series:**

- Dual meets are technically "closed invites."
- <u>February, 2023</u>: JO Max hosted by AZOT Generally teams participating in the Pilot Championship Meet Series cannot swim in both the series and the Committee meet. However, AZOT/Brian Pajer and Pilot Series/Felipe Delgado will discuss and decide if the Pilot Series dual meet swimmers will attend JO Max as their meet for that month.
