Finals Start: Finals will start no earlier than 2 hours after the conclusion of Prelim session.

Entries Due: Entries must be received by 5:00 PM on Tuesday, Feb. 17, 2026. Entry may be received electronically (team entry only; no individual swimmer email entry), USPS, delivery service or hand delivered.

Facility: A twenty-lane 25-yard outdoor pool. Lanes for warm up and warm down will be available throughout the meet. The competition course has been certified in accordance with 104.2.2C (4). The copy of such certification is on file with USA Swimming. Pool depth at start end is 6' 7" and pool depth at turn end is 6' 7".

COMPETITION COURSES: Competition courses (Girls Course and Boy Course) will be determined once meet entries are received. The meet will be contested on two courses for all sessions.

Directions: 360 N. Arroyo Blvd., Pasadena, CA 91103. Please use Google Maps, MapQuest or Thomas Guide for directions. Pool at the far southeast end of the Rose Bowl parking area, past tennis courts. There are signs in the area directing you to the Rose Bowl. The Aquatic Center is 1000 yards directly south of the Rose Bowl. **RV parking is restricted to marked areas. No overnight parking is permitted.**

Warm-up Procedures: Controlled warm-ups will begin on Fri-Sat-Sun at 7:00 AM in the competition pool. At the close of assigned warm-up additional lanes will be available in the adjoining pool. Warm-up procedures will be posted at the pool. Swimmers must be under the supervision of a 2026 USA Swimming member coach during warmups. All swimmers must use a 3-point entry when entering the pool.

Meet Referee: The Meet Referee shall be in charge of the meet, **Omar de Armas <omarswimref@gmail.com>**. Any questions regarding the conduct of the competition should be directed at that person.

Meet Start Times: Preliminary sessions will begin at **8:30 AM** on Friday, Saturday, and Sunday. **Finals** session will begin no earlier than a minimum of 2 hours following the end of the Prelims Session.

Rules: Current USA Swimming Rules, including the Minor Athlete Protection Policies (MAAPP), will govern the meet. All Coaches and Officials must complete the CDC or NFHS concussion and Child Abuse and Neglect Reporting Act online courses, current SCS meet procedures will be in effect and take precedence over any errors or omissions on this form. **Relay check-in each day is due at the end of Prelim session. Relays must be entered by entry deadline.** Swimmers must compete in their age group. Age on Feb 27, 2026, determines the age for the meet. **Prelims events will be run fast to slow.** The Committee championship meet will be contested in two courses -Girls Course and Boys Course.

DISABILITY: Coaches entering swimmers with disabilities that require any reasonable accommodation or modifications, including the need for personal assistants, and/or registered service animals, must provide advance notice in writing (email), accompanying their meet entry file, to the meet referee by the entry deadline. Failure to provide advance notice may limit the host's ability to accommodate all requests.

Backstroke Ledges: Per World Aquatics Rules the backstroke ledge adjustments may not be outside the range of 4 cm above or 4 cm below the water level. 0 cm is the water level. Ledges will be set to -4 cm. Swimmers are not to change the adjustment. If an adjustment to -2 cm is needed, the coach must place that request with the Deck Referee prior to the event.

Change of Affiliation: Club Transfers (unattached or attached) can only be completed online in SWIMS 3.0. At a meet, a swimmer may compete as Unattached but is responsible for completing the Club Transfer process online in SWIMS 3.0.

Finals: Championship Consolation heat of 8 and Championship Final heat of 8 will swim in the Final session. For each individual event, except the 11-12, 13-14 and 15/OV 500 Freestyle events, which will have a Championship Final heat of 8 only. Fastest heat of 1000 and 1650 Freestyle will swim during the final session. All relays will be contested in final session.

Final Scratch Rule: The National Finals' Scratch Rule be used. A swimmer must scratch or place intent on an event within 30 minutes of announcement of preliminary results. Final "no-show" (original top places only), except last day, will be removed from the remainder of the meet. A \$50.00 fine will be assessed to the swimmer for a "no show" in her/his last event of the meet. 19 and Up swimmers will be considered for finals if space is available.

Recording Devices & Media Notice: The use of audio-visual recording devices, including cell phones, is not permitted in locker rooms, changing areas or restrooms. **Recording devices are not permitted behind the starting blocks during the starting sequence throughout the meet.** This meet may be covered by the media, including photographs, video, web casting, and other ways of obtaining images of athletes participating in the meet. Entry into the meet is acknowledgement and consent to this fact.

DRONES: Operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, athlete/coach areas, spectator areas, and open ceiling locker rooms) any time athletes, coaches, officials, and/or spectators are present.

Swimwear: Swimwear must conform to USA Swimming Rule 102.8. Only swimsuits complying with World Aquatics (AQUA) swimsuit specifications may be worn in any USA Swimming sanctioned or approved competition. Tech suits may be worn by 13 and older swimmers only at this meet.

Deck Changes: Deck changes are prohibited.

Racing Start Certification: Any swimmer entered in the meet must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.

Eligibility: Open to Pacific Committee 2026 USA Swimming registered swimmers and chartered clubs. Registration application must be received by Tuesday, **Feb 17, 2026, at 5pm.** **All athletes 18 years or older must complete free online ATHLETE PROTECTION TRAINING to compete.**

Meet Entry Pacific Committee Club Championship: Athletes must have achieved the minimum qualifying time standards stated on meet entry form to enter events. Athletes are limited to participating in **THREE (3) events per day and no more than NINE (9) individual events total for the meet.**

*** Bonus events may be entered using the following formula:

- One qualifying event may enter **THREE (3) Bonus events totaling = Four (4) events**
- Two qualifying events may enter **TWO (2) Bonus events totaling = Four (4) events**
- Three qualifying events may enter **ONE (1) Bonus event totaling = Four (4) events**
- Four or more qualifying events, no bonus events are allowed.

*** Bonus events may only be entered into by swimmers who have entered at least one event in this competition with an achieved minimum qualifying entry time standard. All Selected Bonus events must be 200 yards or shorter. Bonus events will be accepted according to the above schedule. All Bonus events must be entered with participant's achieved time – NTs will not be accepted. Bonus events are to be identified with "B" designator when entered on written Word pdf document.

Entry Limit: A swimmer can swim no more than Nine (9) individual events during the meet, and no more than Three (3) individual events per day.

Submitted Times: The Pacific Committee Championship is a championship meet all swimmers must have achieved a time for all events entered. "No Times" (NT) entries will not be accepted. **Submit ACTUAL times achieved for each event – NO swim-ups.** If entered time is achieved in LONG COURSE METERS, enter event with LONG COURSE METER time, indicated on entry by "L." If entered time is achieved in SHORT COURSE YARDS, enter event with SHORT COURSE YARD time, indicated on entry by "Y." If using a white card, time on front of card must be clearly marked with either "L" or "Y" with proof of time yards/meters on the back of the card. If entering electronically, "L" or "Y" must be indicated on proof of time sheet. Times must have been achieved on or after Sept. 1, 2024, and must be verifiable (meets not in SWIMS are provable only with official results subject to approval by SCS) - refer to SCS Swim Guide. Do not submit NT (no time) or ET (estimated time). Discrepancies in submitted times may lead to disciplinary action. Coaches, swimmers & parents are reminded that this is a **proof-of-time** meet. **NOTE: All entry times will be verified through the USA SWIMS database.**

Scoring: This is a team-scoring meet. Points and awards will be given for 9-10: 11-12; 13-14; 15-UP age groups scoring in the final sessions of the meet. Teams are allowed 2 scoring relays per event, age group, and gender. The top 16 placing relays will be awarded and scored.

Awards: Team trophies are to be awarded 1st to 6th Gold and Silver Levels if requested. Teams will be divided into levels according to the total number of splashes entered in the meet. Distinctive custom medals will be awarded for 1-8 places in all individual events and 1-3 in relay events. Ribbons will be awarded for places 9-16 in individual events and 4-8 for relay events. Swimmers 19 years older are not eligible for awards.

Relays: Must be per-entered by meet entry deadline. This is a championship meet. All relays will be contested in event order in the final session each day. **Relay only swimmers must be pre-entered for registration verification.** Coaches must turn in relay check-in and scratches by the end of prelims each day. **Teams are limited to entering four (4) team relays per event and only two (2) relays per team per event are eligible for scoring.** The top 16 placing relays will be awarded and scored.

Distance Events:

- The 1650-yard Freestyle events (age groups combined) will be swum:
 - 1650 will be awarded and scored as one age group per gender.
 - Swimmers in the 1650 Freestyle need to supply their timers and lap counters.
 - Check-in for seeding of 1650 Freestyle closes at 9:30AM Sunday. The top 8 athletes checked in and not requesting an AM swim will swim in finals in the event order listed.
 - The 1650 Freestyle will be awarded and scored as one age group.

- The 1000-yard freestyle events (age groups combined) will be swum:
- Check-in for seeding of 1000 Freestyle closes at 9:30 AM Saturday. The top 8 athletes checked in and not requesting an AM swim will swim in finals in the event order listed.
- Swimmers in 1000 Freestyle need to supply their timers and lap counters.
- All heats fastest to slowest, boy and girl courses.
- The 1000 Freestyle will be awarded and scored as one age group.

Entry Procedure: Team Electronic Entry is highly preferred. Electronic entry will be accepted ONLY when received with an attached Word or pdf file including electronic signature of coach AND PROOF OF TIME and will be dated as official at that time (5PM postmark would queue before a 10PM electronic). Full payment (single team check or certified funds) for an e-mail entry must be postmarked within 48 hours of the e-mail entry or paid to Admin Official on the first day of the team participation. Failure to comply will be referred to the SCS Board of Review. Entry updates (added events) will be processed when received by the processor by the entry deadline. Added events (entered swimmers) may be submitted by hard copy (this includes e-mail) ONLY. DO NOT RESEND AN ENTRY FILE: A replacement file for the team will NOT be processed. Deletions will NOT be refunded. Returned checks will incur a service fee per SCS policy. **Electronic entries are to be sent to blwmeetprocessor@gmail.com.** For an individual entry, submit a Southern California Swimming Consolidated Entry Card for each swimmer. Card must be filled out, including entire USA Swimming registration number. To avoid concern regarding receipt of the designated address, enclose a stamped, self-addressed envelope or postcard. (Receipt of entries will not be verified by phone or e-mail.) **Individual email entry will not be accepted. NO REGISTERED, SPECIAL DELIVERY OR CERTIFIED MAIL WILL BE ACCEPTED.**

Fees: Individual event entry charge of **\$8.00 per entered event.**

- **\$35.00 swimmer surcharge** (\$20.00 swimmer surcharge and \$15.00 facility surcharge) per athlete must accompany each entry. **All relay only swimmers must pay \$35.00 swimmer surcharge.**
- Relays \$20.00 per relay. Relays must be per-entered.
- OUTREACH registered swimmer meet entry is \$15.00 total. Teams must provide proof of outreach status by including a copy of their team roster when submitting entries.

USA SWIMMING MEET 360:

Permanently suspended or ineligible individuals cannot be present on deck, coach, or perform any function at a meet requiring USA Swimming membership.

During registration, ensure all coaches, officials, trainers, massage therapists, LSC or host club staff, and medical professionals show proof of current USA Swimming membership (e.g., require them to show their Membership Card via the USA Swimming app) at registration. If such an individual cannot demonstrate proof of membership in good standing, deck access will not be granted.

Individuals permanently suspended or ineligible can be spectators at a meet and may be in the stands.

Violators shall be reported to the Meet Director or Meet Referee, who can then direct that individual to the spectator area. A subsequent report should also be made to USA Swimming.

A quality control system has been implemented to ensure that individuals who are ineligible for participation are unable to participate in this competition. Additionally, all adult members of USA Swimming who have not completed their Athlete Protection Training will not be able to participate in this competition.

Pursuant to USA Swimming Rules and Regulations and federal law, it is every member's responsibility to immediately (i.e., within 24 hours) report any incident of child abuse, including physical or sexual abuse, to law enforcement and the U.S. Center for SafeSport. Reporting must occur when an individual has firsthand knowledge of misconduct or where specific and credible information has been received from a victim or knowledgeable third party. A report to the U.S. Center for SafeSport may be made via telephone at 833-5US-SAFE (833-587-7233) or online at www.uscenterforsafesport.org/report-a-concern. Various state laws may also require reporting to law enforcement or to a designated child protection agency.

TIME TRIALS: Sanction #: S26-066

- 1) Time Trials will be conducted on a time-available basis and are limited to approximately one hour.
- 2) Entries for Time Trials will be conducted with cash or check made out to Rose Bowl Aquatics Booster Club. PAYMENT AT TIME OF ENTRY IS REQUIRED.
- 3) Athletes must be entered in the meet and have paid the athlete surcharge to swim in Time Trials.
- 4) Each time trial swum will count toward the event limit with a combination of time trials and individual meet events not to exceed three (3) per day or nine (9) events total for the meet.
- 5) Events offered will be limited to the events on the Time Trial announcement.
- 6) Distance events (400 Individual Medley / 500 Freestyle/ 1000 Freestyle and 1650 Freestyle) will be contested one day only. Event day will be specified on meet announcement.
- 7) Relay only swimmers will be allowed to swim in time trials.
- 8) Participants must provide their own back-up lane timers.
- 9) Time Trial Entry Fees: \$20.00 per event entered - \$40.00 per relay.
