POOL: Tahquitz High School 4425 Titan Trail, Hemet, CA 92545

DIRECTIONS: From Temecula: 215 north, exit Newport, go east (right). Newport turns into Dominagoni Pkwy. Go north (left) on Sanderson Ave. Turn west (left) on Easton. At first stop sign, Cawston, go north (right). School is on left. From San Bernardino: 10 east toward Beaumont, exit Beaumont Ave. go south on Hwy 79 (right). Hwy 79 turns into Sanderson Ave. Turn west (right) on Esplande. Next street go south (left) on Cawston. School is on the right. From Corona: 91 east, then 60 east to 215 south. Go east on Ramona Expwy.Turn south (right) on Sanderson (Hwy 79). Go west (right) on Esplanade. Next street go south (left) on Cawston. Take first driveway all the way to back. Pool is adjacent to football

<u>COURSE</u>: Outdoor 50 meter x 25 yard with 8 competition lanes and additional warm-up lanes. The competition course has been certified in accordance with 104.2.2(C). Pool depth: start end 14', turn end 4.5' The competition course has been in accordance with 104.2.2 (c), on file with USA Swimming.

<u>WARM-UP Procedures:</u> All lanes will be open for USA Swimming Member Coach supervised warm-up between 7:00 – 8:15 am. Diving will be allowed in designated dive lanes only under the supervision of the coaches and marshals. Dive lanes will be assigned Dive lanes will open 45 minutes before the start of the meet. The pool will close 15 minutes before the start of each session. **All swimmers must use 3-point, slide in entries into the pool during warm up, no jumping or diving.** 

<u>MEET REFEREE:</u> The meet referee will be in charge of the meet. Any questions regarding the conduct of the meet should be directed to the referee: Mike Sheppard cattywampus@roadrunner.com

<u>RULES:</u> USA Swimming rules will govern. Current SCS meet procedures will be enforced and take precedence over any errors or omissions on this form. Swimmers must swim in their actual Age Group as determined by their age on the first day of the meet. Swimmers must be at least 5 years old on **September 24, 2022**, to enter this meet.. Events will be swum fastest to slowest. All coaches on deck must complete the CDC or NFHS concussion course. In order to compete, all athletes 18 or older must complete the free online ATHLETE PROTECTION TRAINING (APT).

CHECK IN: SWIMMERS MUST CHECK IN with the clerk of course 40 MINUTES PRIOR TO THE START OF EACH SESSION FOR THE FIRST 4 EVENTS OF THAT SESSION. After the event has been officially closed, SWIMMERS MAY NOT CHECK IN OR SCRATCH. Contingency Check In: If conditions warrant, the meet may be deck-seeded 45 minutes before the start of each session after coaches' scratches or pre-seeded. This meet will follow all State, Local and Facility guidelines as it pertains to Covid-19. Meet check-in may or may not be available depending on the site's guidelines.

**RECORDING DEVICES & MEDIA NOTICE**: The use of audio-visual recording devices, including cell phones, are not permitted in locker rooms, changing areas or restrooms. **Recording devices are not permitted behind the starting blocks during the starting sequence throughout the meet.** This meet may be covered by the media, including photographs, video, web casting and other formsof obtaining images of athletes participating in the meet. Entry into the meet is acknowledgement and consent to this fact.

<u>DRONES:</u> Operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, athlete/coach areas, spectator areasand open ceiling locker rooms) any time athletes, coaches, officials and/or spectators are present.

**SWIMWEAR:** Please see USA Swimming Rule 102.8 in the 2022 USA Swimming Rule Book (page 32-34). Only swimsuits complying with FINA swimsuit specifications may be worn in any USA Swimming sanctioned or approved competition.

**DECK CHANGES**: Deck changes are prohibited.

**RACING START CERTIFICATION:** Any swimmer entered in the meet must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.

<u>ELIGIBILITY:</u> Open to Southern California Swimming athletes who hold 2022 or 2023 USA Swimming Registration. SCS athletes must be members of Eastern Committee Teams:. Registration application **must be received by the meet entry deadline** by meet processor, administrative referee, or SCS Office. Late application will be considered "on-deck" subject to penalties in SCS Swim Guide, Part One, III, B. Registration application may be submitted with entry form. **In SCS age group meets, swimmers 18 & younger must prove birth dates prior to** competition.

<u>CHANGE OF AFFILIATION:</u> Before the meet, a swimmer may change affiliation by submitting a **Club Transfer form** to the Swim Office. At the meet, a swimmer may UNATTACH (may not attach or reattach) by notifying the Administrative Referee in writing and paying the appropriate fee.

<u>SUBMITTED TIMES:</u> Times submitted must be the **best recorded times** short course or long course from this or the preceding swim season (**NO WORK OUT TIMES**). Coaches and swimmers should be prepared to verify all submitted times. Swimmers must have

achieved time standards listed for an event. Discrepancies in submitted times could lead to disciplinary action. After entries close, non-conforming times will be converted by meet admin for seeding purposes only.

<u>Entry Limit:</u> A swimmer may swim no more than **FOUR (4)** individual events per day. The meet will conform to the 4-hr rule. **Entries will be processed in the order of first received, first entered.** In the event that the meet fills up before all the entries have been processed, the meet host reserves the right to limit the entries to THREE (3) individual events per day.

<u>ENTRY FEES:</u> \$4.00 for each INDIVIDUAL EVENT along with a \$10.50 SURCHARGE per swimmer must accompany each individual entry card. There is a charge of \$10.00 for each relay. Returned checks will incur a service fee per SCS policy. NO REFUNDS. Deletions will not be refunded. Please make Checks payable to: Hemet Valley Dolphin Aquatics

Entry Procedure: Team Electronic Entry is highly preferred. Electronic entry will be accepted ONLY when received with an attached Word or pdf file including electronic signature of coach and will be dated as official at that time (5PM postmark would queue before a 10PM electronic). Full payment (single team check or certified funds) for an e-mail entry must be postmarked within 48 hours of the e-mail entry. Failure to comply will be referred to the SCS Board of Review. Entry updates (added events) will be processed when received by the processor by the entry deadline. Added events (entered swimmers) may be submitted by hard copy (this includes e-mail) ONLY. DO NOT RESEND AN ENTRY FILE: A replacement file for the team will NOT be processed. Deletions will NOT be refunded. Returned checks will incur a service fee per SCS policy. For an individual entry, submit a Southern California Swimming Consolidated Entry Card for each swimmer. Card must be completely filled out, including entire USA Swimming registration number. To avoid concern regarding receipt of entry card the designated address, enclose a stamped, self-addressed envelope or postcard. (Receipt of entries will not be verified by phone or e-mail). Individual email entry will not be accepted.

ENTRIES CLOSE: ENTRIES MUST BE RECEIVED BY THE MEET PROCESSOR NO LATER THAN 5 PM, Wednesday, September 14, 2022. IF THE MEET FILLS PRIOR TO THE DEADLINE, ENTRIES WILL BE REJECTED (LAST RECEIVED, FIRST REJECTED).
