Eligibility: Open to 2025 or 2026 USA Swimming registered swimmers who have met and can prove the SCS "Winter Age Group Invitational" time standards shown on this meet form. 180 swimmers from outside SCS will be accepted on a first come first served basis at each site. Registration application must be completed online in SWIMS by 5 PM, Wednesday, December 3<sup>rd</sup>. Athletes with a disability are welcome to attend this meet and should contact the Meet Director or Meet Referee regarding any special accommodations on entry times and seeding according to SCS Swimming policy. All athletes 18 years or older must complete the free online ATHLETE PROTECTION TRAINING (APT) prior to the start of the meet in order to compete. No swimmer will be permitted to compete unless the swimmer is a member as provided in Article 302 of the USA Swimming Rules and Regulations.

**Facility:** GOLDEN WEST COLLEGE POOL, 15744 GOLDENWEST STREET, HUNTINGTON BEACH, CA The competition pool is an outdoor, 50-meter pool. 25 yard competition area with (twenty) 20 swimming lanes, and a separate 4 lane warm-up area. This competition course with bulkhead in position has been certified in accordance with 104.2.2 ( C ) on file with USA Swimming. Pool Depth Dimensions at Start end = 9', Turn end = 8.5'. A 25-yard warm-up pool will be available throughout the meet. The competition course has been certified in accordance with 104.2.2(C), on file with USA Swimming. Colorado pads and timing system, starting blocks (w/wedge) and Finis backstroke ledges.

<u>Medical Supervision:</u> There are no Lifeguards on duty, AED unit is available and 911 call buttons in the case of an emergency.

<u>Directions:</u> Take 405 freeway north or south to Goldenwest Street. Go South on Goldenwest Street past McFadden to Golden West College and use Parking Lot A, sections 1-2 near the Pickle ball courts for access the pool. Parking permits are required Monday – Friday, Weekends are free.

<u>Partially Closed Deck:</u> Prelims and Finals will be run with a partially **CLOSED DECK**. Several deck areas (including behind the starting blocks, behind coaches, and in tented swimmer area) will be restricted to coaches, officials, athletes and volunteers. Parents will be restricted from these areas.

<u>Meet Start Times:</u> Friday, Saturday and Sunday Prelims will start at **8:30 AM**. Finals will begin no sooner than 2 hours after the completion of the prelim session that day.

<u>Warm-up Times:</u> Warm-ups will be split, and teams will be assigned to specific warm-up times on Fri/Sat/Sun beginning at 7:00 AM in the competition pool. The competition pool will be closed at 8:20 AM, with supervised warm-up/warm-down available in the adjoining pool. Warm-up procedures will be posted at the pool. Swimmers must be under the supervision of a USA Swimming member coach during warm-up, and jumping or diving.

<u>Rules:</u> USA Swimming Rules govern; current SCS meet procedures will be in effect and take precedence over any errors or omissions on this form.

- Coaches must declare scratches daily. The swimmers/events page for each day will be available the night before. Scratches close 1 hour before the start of prelims.
- Swimmers must compete in their own age group. Age on December 12, 2025, determines the age for the
  meet
- Prelims and timed finals sessions will be swum slow to fast.
- Prelim sessions and distance events may be swum in two (2) courses, if necessary.
- All coaches and officials on deck must complete the CDC or NFHS Concussion course and must complete the CANRA Mandatory Reporting course prior to the start of the meet. All persons acting in any coaching capacity in a sanctioned event must be a coach member of USA Swimming.

<u>The National Finals' scratch rule</u> will be used. A swimmer must scratch or place an intent to scratch an event within 30 minutes of the announcement of preliminary results. Final "no-show" (original top 20 places for each age group), except last day, will be removed from the remainder of the meet. A \$50.00 fine will be assessed to any swimmer for a "no show" in her/his last event of the meet. This fine must be paid before any future competitions in SCS.

Recording Devices & Media Notice: The use of audio-visual recording devices, including cell phones, is not permitted in locker rooms, changing areas or restrooms. Recording devices are not permitted behind the starting blocks during the starting sequence. This meet may be covered by the media, including photographs, video, web casting and other ways of obtaining images of athletes participating in the meet. Entry into the meet is acknowledgement and consent to this fact.

<u>Unaccompanied Athletes:</u> Any USA Swimming Athlete-Member competing at the meet must be accompanied by a USA Swimming Member-Coach for the purposes of Athlete supervision during warm-up, competition and warm-down. If a Coach Member of the Athlete's USA Swimming Club does not attend the meet to serve in said supervisory capacity, it is the responsibility of the Athlete or the Athlete's legal guardian to arrange for supervision by a USA Swimming Member-Coach. The Meet Director or Meet Referee may assist the Athlete in making arrangements for such supervision; however, it is recommended that such arrangements be made in advance of the meet by the Athlete's USA Swimming Club Member-Coach.

<u>Racing Start Certification:</u> Any swimmer entered in the meet must be certified by a 2025 USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water without the use of a backstroke ledge. When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.

<u>Drones:</u> Operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, athlete/coach areas, spectator areas and open ceiling locker rooms) any time athletes, coaches, officials and/or spectators are present.

<u>Swimwear:</u> "Tech suits" (suits with bonded seams, kinetic tape or meshed seams) are not permitted at this meet for all 12 & under swimmers. 13&over swimmers are allowed to wear "tech suits" that conform to USA Swimming Rule 102.8. Only swimsuits complying with AQUA swimsuit specifications may be worn in any USA Swimming sanctioned meet. Please see the Tech Suit Policy on the SCS website: <a href="www.socalswim.org">www.socalswim.org</a> Deck Changes: Deck changes are prohibited.

<u>Change of Affiliation:</u> Club Transfers (unattach or attach) can only be completed online on SWIMS 3.0. At a meet, a swimmer may compete as Unattached but is responsible for completing the Club Transfer process online in SWIMS 3.0.

#### **Distance Event:**

- The 1000-yard freestyle events will be swum age groups combined:
  - Eligibility to swim is 1000 Freestyle standard on this meet form, the 1650 Freestyle standard or the 1500 Freestyle Summer Age Group Championship time standard. Qualifying by non-conforming times enter at 1000 Freestyle minimum time.
  - All heats fast to slow, alternating girls & boys in 10 lane course.
  - The fastest 10 swimmers who check in will swim in finals.
  - The 1000 freestyle will be awarded and scored as one age group per gender.
  - Swimmers in the 1000 freestyle need to supply their own timers and lap counters.

• 500 Freestyle will be timed finals for 11-12 in the Prelim session. There will be one heat in finals for 13-14 and 15 & over.

Awards: Individual - 1st-8th places, custom medals.

Relays - 1st-3rd place teams, custom medals.

**Scoring:** Top 20 individuals and top 20 relays will score.

**Relays:** Relays and relay-only swimmers must be pre-entered electronically and prepaid (\$20 per relay and \$33.00 per relay-only swimmer, which includes a swimmer and facility surcharge).

- Relays are all timed finals events. Teams may enter a maximum of three relays per event (A, B, C).
- Teams may elect to swim their relays at the end of the prelim session on Fri/Sat/Sun. If swimming at the
  end of the prelim session, they must be checked-in and declared as AM relays by 9:30 AM each day.
   Enter AM or PM relays depending on preference. AM and PM relays will be combined for results and
  scoring.
- Only A&B relays will be eligible for scoring. All other relays will be allowed to swim as exhibition.
- Relays must be checked in by the end of prelims Thurs/Fri/Sat/Sunday for those swimming with finals.
- Times may be proven based on the aggregate of the team's fastest 4 swimmers in that age group over the qualifying period (since 9/1/2024). A team time achieved during the qualifying period may also be used.
- A club entering multiple relays MUST use the aggregate of each listed swimmer's individual best times. Swimmers used to prove relays must be in the age group of the relay on the first day of the meet. Team times are not allowed for multiple relays. Entries must be proven by a team time achieved in the qualification period or an aggregate of 4 swimmers of proper age as of December 12<sup>th</sup>.

<u>Finals</u>: A championship final (10 swimmers, 1-10) and consolation final (10 swimmers, 11-20) will be offered for 7-10, 11-12 and 13-14 and 15&over age groups, except for 500 Freestyle which will be 1 heat of each. **The national finals' scratch rule will be used** (see details above).

<u>Submitted/Qualifying Times:</u> This is a proof-of-time meet. Proof of time is required through SWIMS, the National Times database, or recognized AQUA competitions. Times must be achieved at

- (a) a USA Swimming sanctioned competition,
- (b) a USA Swimming observed competition,
- (c) a USA Swimming approved competition, or
- (d) a AQUA approved competition.

Submit ACTUAL times achieved for each event. If Standard is achieved in SHORT COURSE YARDS, enter event with SHORT COURSE YARD time, indicated on entry by "Y". If Standard is achieved in LONG COURSE METERS, enter event with LONG COURSE METER time, indicated on entry by "L". When entering electronically, "L" or "Y" must be specified and a proof of time report included. If using an individual entry form, time must be clearly marked with either "L" or "Y". Times must have been achieved on or after Sept. 1, 2024, and must be verifiable (meets not in SWIMS are provable only with official results subject to approval by SCS) - refer to SCS Swim Guide. Discrepancies in submitted times may lead to disciplinary action.

<u>Entry Limits:</u> A swimmer may <u>enter no more than 9 individual events</u>; <u>may swim no more than 6 individual events during the meet</u>, or more than 3 individual events per day.

**Bonus Events:** All Bonus events must be National BB or faster – NO NTs.

- One qualifying event may enter 2 Bonus events totaling = 3 events.
- Two qualifying events may enter 1 Bonus events totaling = 3 events
- Three qualifying events may enter 1 Bonus events totaling = 4 events
- Four or more qualifying events, no bonus events are allowed.
- The bonus events chosen must be 200 yards or shorter.
- Bonus events are to be identified with "B" designator when entered in Meet Manager program

#### Entry Procedure: Team Electronic Entry is highly preferred.

- Electronic entry will be accepted ONLY when received with an attached Word or pdf file including electronic signature of coach AND PROOF OF TIME and will be dated as official at that time (5 PM postmark would queue before a 10 PM electronic).
- Full payment (single team check or certified funds) for an e-mail entry must be postmarked within 48 hours of the e-mail entry. Failure to comply will be referred to the SCS Board of Review.
- Entry updates (added events) will be processed when received by the processor by the entry deadline.
- Deletions will NOT be refunded.
- Returned checks will incur a service fee per SCS policy.
- For an individual entry, submit a Southern California Swimming Consolidated Entry Card for each swimmer.
  The card must be completely filled out, including the entire USA Swimming registration number. To avoid
  concern regarding receipt of the entry card at the designated address, enclose a stamped, self-addressed
  envelope or postcard (Receipt of entries will not be verified by phone or e-mail).

#### NO REGISTERED, SPECIAL DELIVERY OR CERTIFIED MAIL WILL BE ACCEPTED.

<u>Fees:</u> \$8.00 for each INDIVIDUAL EVENT, plus \$33.00 SURCHARE (\$25.00 Athlete Surcharge and \$8.00 Facility Surcharge) per swimmer must accompany each individual entry card, Relays: \$20.00.

Entry fee for each OUTREACH registered swimmer is \$15.00 total. Coaches must inform the Meet Admin of the qualified Outreach athletes by the <u>due date</u> for the meet. Qualifying outreach swimmers will be verified with SCS. Returned checks will incur a service fee per SCS policy.

#### Time Trials (Time Permitting): Separate Sanction #S25-261

- Will be swum, time permitting, on Friday, Saturday and Sunday following the preliminary sessions.
- Three (3) events per day limit applies (Championship events + Time trials = 3 events per day or less).
- An event may be swum only once as a time trial.
- Deck entered entry fee is \$20.00 per event, no refunds after seeding.
- The Administrative Referee/Official will determine the order of events.
- Open only to 2025 SCS swimmers who are entered in at least 1 individual event or relay in the meet.
- Participants must provide their own backup timers.

Distance events: 1000 Free, and 400 IM will be offered only one day, to be determined once entries are

- Enter events \*\*185-186\*\* (13-14/15 & over 200 Medley Relay) with 200 Medley Relay times.
- All relays will swim in event order during finals. A&B relays will be eligible for scoring. All other relays will be allowed to swim as exhibition. Teams may enter a maximum of three relay teams per event (A, B, C).
- Enter AM or PM relays depending on preference. AM and PM relays will be combined for results and scoring.
- If time available to swim AM relays those entries must be turned in no later than beginning of finals the day before swim.
